I _____ grant MS Talent the absolute and irrevocable right to act as my Manager in pursuing and securing temporary employment for me and negotiating payment for my employment. I will not discuss fees and payment with the client. (Payment info will be provided when job is booked) and agree that all fees are paid by the client directly to MS Talent. Should talent receive payment for booking directly, talent must forward a copy of pay stub with 20% commission (gross income) to MS Talent immediately. MS Talent will sue for any legal fees should legal action need to be taken for commissions owed to us from talent. You will pay MS Talent attorney fees if MS Talent proves that you have failed to forward commissions, payment or any other money due.

I will have a 20% Manager fee deducted from all my earnings through MS Talent, if the job is booked through then. And if the job is booked through MS Talent agent I will have a 20% fee deducted from my earnings. (10% for the manager and 10% for the agent). I agree not to pursue, discuss, or work directly for MS Talent, Client. (Agent, Casting directors, Directors, Photographers, and Make up Artist or any one MS Talent sent you to The talent agrees that to do so is a breach of contract, making the talent responsible for all monies and fees due upon completion of said bookings, including cost of legal fees incurred during recovery.

This is a Non- Exclusive Contract. I have no agreement with MS Talent other than this Freelance Contract. This agreement may only be change in writing signed by both parties. It is understood and agreed that any work performed by me will be as an independent contractor representing MS Talent, not as an employee of MS Talent. Therefore a 1099 form will be issued. As such, I understand that I am personally responsible for filing and reporting all monies earned to the IRS and do not hold MS Talent liable for taxes due on my income.

I agree to promptly inform MS Talent, of the results of interviews secured for me by MS Talent, and I will promptly notify MS Talent of employment accepted by me. When requested, I agree to supply MS Talent with resumes, photographs, photo reproductions and videos, audios and/or cassette tapes. I hereby give MS Talent the right and permission to use or publish photographs, videos with my name in any legitimate way they deem proper... Photos and videos submitted to MS Talent becomes the property of MS Talent and will not be returned.

In the event of cancellation of the performance for which talent is responsible or for a reason originating with the talent or within her/his area of responsibility, the talent is liable to the Promoter for the amount of the deposit only. Should the talent or a member of her/his group fall ill, notification must be provided within 2 business days of the occurring illness. In this event, the talent will be released from her obligation to perform on that date, and a make-up date shall be decided upon. Should the talent fail to inform the Promoter within 2 business days of the occurring illness, the talent will be liable to the Promoter for the amount of the deposit?

NO SHOW FOR BOOKING:

Talent will pay MS Talent 20% commission based on the pay rate for the particular booking that talent did not show up for plus all penalties incurred by client.

I relinquish to MS Talent all right, title, and interest I may have in the finished pictures, negatives, reproductions, and copies of the original prints and negatives and further grant MS Talent the right to give, transfer, and exhibit same to any responsible individual, business, firm or publication, or to any of their assignees. I hereby release and discharge MS Talent and Managers Representative, Agencies and

assignees from all claims and demands arising out of or in connection with the use of photographers including without limitations; any an all claims for invasion of privacy, right of publicity, and defamation. This agreement is been made and entered into the laws of the State of New York and shall be governed and interpreted in accordance of the laws of New York-USA. This agreement embodies the entire agreement of the production team (Management, Managers, Agencies, Talent, Makeup, Hair Stylist, Wardrobe Stylist, Creative directors, Photographers, Assistant, Producers, Casting Directors, Movie Directors, and Locations.

I agree and promise I will never ever disrespect the casting directors/client and I will keep conversations with them at a minimum and always be polite and cordial. (They do not have time for feedback, chit chat or to hear why the child/you are having an off day) People are entitled to off days. If not today then tomorrow!

In the event I encounter any non-operational problems while on an assignment, I promise and agree to contact MS to discuss the issue, not the client. The non-operational problems referred to in this paragraph include any complaint or concern about harassment or discrimination, unfair or abusive treatment, unsafe working conditions, and similar matters. MS Talent will promptly investigate any such complaint, and will take prompt, appropriate corrective action where necessary.

I acknowledge and agree that while working on an assignment at a client of MS Talent, I may be entrusted with confidential information, trade secrets, and/or proprietary materials of such client. Except as authorized by any client to which I am assigned, or except as otherwise authorized by such client pursuant to any agreement between such client and MS Talent, I promise and agree not to remove any property or materials belonging to any MS Talent client from the client's premises, or to use or disclose to any person any confidential information, trade secrets or proprietary materials of the client (except as necessary to perform my duties or as otherwise authorized). I also agree to deliver promptly to any such client (on request or on the date of termination of my assignment) all documents, copies thereof, and other materials that are the client's property.

I represent that I am (18) years and if i am under that age to bring my parents/guardant to agree the terms herein above. I have read the foregoing and fully understand it content.

This release shall be binding upon me, my heirs, legal representative and assign. Upon signing this agreement I hereby understand I am considered an independent contractor and take total responsibility for any injury, accident, or liability that may be incurred while working for said account and hold harmless from all claims.

I HAVE READ AND UNDERSTAND THE ABOVE THAT (MS TALENT) IS NOT AN EMPLOYMENT AGENCY AND DOES NOT GUARANTEE JOBS, AND THAT MY SELF/CHILD MAY NEVER BE CALLED FOR A JOB, DESPITE THE EFFORTS OF MS TALENT.
